1. CALL TO ORDER AND ACKNOWLEDGEMENT OF FIRST NATIONS TERRITORIES



The committee supported the following motions going forward to the Board:



4.2 <u>Energy Management Update – Climate Change Accountability Report – Mhairi Bennett</u>

The Director of Facilities presented the Climate Change Accountability Report to the committee and noted that the 2030 target is baselined to 2010 and does not account for the growth in facilities and student population since that time. In addition, staff are working towards leveraging grants to support an energy specialist to be onboarded and further maximize our use.

- 4.3 Transportation Update School Bus Registration 2025/26 Randy Cobb
 The Manager of Transportation provided an update on bus registrations and next steps and continued exploration of alternative systems for registration and payments.
 Questions were addressed related to the drop in early registrations compared to last year, appreciation for the shared communication with SPEAC and an update on implementation of the student bus card, which has supported ridership as well as parent communication. Implementation of the parent app associated with the cards is being tested for future implementation once all the testing is completed.

Agenda Item 4.1 – 2026/2027 Minor Capital Submission

ISSUE: Endorsement for the Minor Capital Submission to be submitted to the board for approval at their September 23, 2025 meeting.

BACKGROUND / FACTS:

- The district is required to submit a minor capital plan to the Ministry as approved by the Board by September 30th.
- For SEP and CNCP, the district uses an evidence-based approach through a tool called VFA, that calibrates data inputs based on building systems and structures and their maintenance and replacement history, produces a Facilities Condition Index (FCI).
 - The VFA is an industry standard tool and process for large organizations with multiple buildings and is also used by the Provincial Government, Health Sector and Post-Secondary institutions to manage their built infrastructure.
- The major capital plan due date is June 30th annually and includes the Seismic Mitigation, School Expansion, School Replacement, Rural Districts and Building Envelope programs.

MINOE CAPITAL PLAN COMPONENTS:

• The minor capital submission includes the following programs:

Program	Description
School Enhancement Program (SEP)	Intended to help school districts extend the life of their facilities through a wide range of improvement projects
Carbon Neutral Capital Program (CNCP)	Provides specific funding to energy-efficiency projects that lower the school districts carbon emissions.
Bus Acquisition Program (BUS)	Provides specific funding for new buses (growth) and replacement buses (end of life)
Playground Equipment Program (PEP)	Provides specific funding to purchase and install new or replacement playground equipment that is universal in design
Food Infrastructure Program (FIP)	Provides specific funding to support minor upgrades to support the delivery of prepared meals from centralized kitchen facilities to schools
Childcare Conversion/Minor (CC Minor/Equipment)	Provides dedicated funding to support small-scale projects to convert (renovate) an existing K-12 space to create childcare spaces as well as the purchase and installation of fixtures, furniture and equipment required to obtain a license.







September 16, 2025 Agenda Item 4.3 – Initial Enrolment Update

ISSUE: Enrolment estimates provided to give the Committee an initial assessment of the direction that enrolment is heading compared to projections.

BACKGROUND:

- Estimates will be refined leading up to the district submission to the Ministry 1701 process.
- Initial reports are based on FTE for Standard (Regular) Enrolment only, no International, Continuing Education or Online Education.

ANALYSIS:

- The 25/26 projections that were submitted to the Ministry in February 2025 were an estimated K-12 Standard Enrolment FTE of 13,700.
- Based on initial reporting from the schools, the District is estimating a total K-12 Standard Schools FTE amount of 13,599
- The breakdown of this amount by level is reflected in the following table:
