- **Registration** at least 150 more students to be added to the district-in two years, district will grow-Budget is being worked on as there has been some growth in the Budget-budget meeting dates to follow-getting ready to have more staff in schools – French immersion
- **Nature Kindergarten** is looking for one more girl to register at Sangster Elementary
- **High Schools-**meetings happening all of the time 3 years will go by fast- Feb 22, 2012 at Spencer at 7pm first consultation

Parent Concern - Crystal View, is it still a fine arts school? -it still is a fine arts school just not with provincial registration – no students coming from out of catchment as school is growing

Trustee-Denise Riley

- **High schools-**not official, but rumor is they will be opening 2015 for both schools- focus groups open to parents and focus groups Feb 22, 2012 at Spencer March 8 & 14-no locations yet times 7pm-9pm- March 28 & 29 for broader public opinions- location to be decided-May 23 & 24 last dates for consultation
- **Budget Process** -Feb 21 6:30pm at SBO Boardroom transportation review to start, 7:30pm the whole Budget Presentation
- Emergency Preparedness Policy learned protocols this will be going to Education committee – will go through review process

• Independent Fact Finder set to find a way to get negotiations moving between the Minister and Teachers -Feb 23, 2012 is the date a response is going to be made by government –ten years ago 25% was spent on education and now 15% is being spent-teachers are fighting for funding, not wages-1998, last local negotiation, class size and composition was the big issue, improvements to personal development was wanted, this was given up, -2002-these items that were given in 1998 were taken out in 2002, the teachers want it back
