Please note that all Public Board and Committee meetings are now held in person at the District School Board Office, located at 3143 Jacklin Road, Victoria.







# Board Info Note Public Board Meeting July 25, 2023

# **Agenda Item 10.1: School Trustee Elections and By-Elections**

- As previously communicated to the Board, Trustee Parmar has provided his resignation to the
   Secretary Treasurer with an effective date of the close of business on July 27, 2023
- Section 51 of the School Act (highlighted below) indicates the details around the resignation:

#### Resignation from office

- 51 (1) A trustee may resign from office by giving written notice to the secretary treasurer of the board.
  - (2) The secretary treasurer must notify the board of a resignation at its next meeting after the resignation is received or, if there are no other trustees on the board, the secretary treasurer must notify the minister.
  - (3) A resignation is irrevocable after it is given to the secretary treasurer and is effective from the date a successor takes office or at an earlier date stated in the resignation.
  - Based on this resignation, the Board is required to host a by-election to fill the vacancy per section 36
    of the School Act as noted below:

#### **By-elections**

- 36 (1) Except as permitted under subsection (2), an election must be held to fill a vacancy on a board that occurs in any of the following circumstances:
  - (a) a person elected or appointed as trustee dies before taking office or a trustee dies while holding office;
  - (b) a trustee resigns under section 51;
  - The proposed dates for the by-election have been attached for the Board's information
  - In order to host the required by-election, the Board must pass a Trustee Election By-law
  - The existing School Trustee Elections By-Law No. 1-18 (attached) does not allow for by-elections and therefore the new School Trustees Elections and By-Elections By-Law No. 1-23 (also attached) is required to be passed in order to allow for the necessary by-election
  - Section 36(3) of the School Act (highlighted below) requires the Board to appoint a Chief Election
     Officer for the by-election
  - Staff recommend that Joan Axford be appointed as the Chief Election Officer given her experience providing the same role for School District #61 and her familiarity with our District
  - Staff also recommend that Kris Ross be appointed Deputy Chief Election Officer as was her role during the last general election held in the fall of 2022

- (3) Within 30 days after a vacancy occurs for which an election is to be held, the board must do the following:
  - (a) in the case of a trustee election required to be conducted by the board, appoint a chief election officer;
  - (b) in the case of a trustee election required to be conducted by a municipality, notify the municipal council of the election;
  - (c) for an election under paragraph (a) or (b), notify the minister of the election.
  - Staff recommend the Board consider the following motions:

# BYLAW NO. 1-18 TRUSTEE ELECTIONS and BY-ELECTIONS

A bylaw to provide for the determination of various procedures for the conduct of general school elections and other trustee elections.

#### 1. Preamble

Trustee elections in the following trustee electoral areas are being carried out by School District No. 62 (Sooke):

The Board of Education, in an open meeting of the Board, enacts as follows:

#### 2. Definitions

The terms used shall have the meanings assigned by the *School Act, the Local Elections Campaign Financing Act* and the *Local Government Act*, except as the context indicates otherwise.

"Board" or "School Board" means the Board of Education of School District No. 62 (Sooke).

"By-election" means a trustee election to fill a vacancy on the school board in any of the circumstances described in section 36 of the *School Act*.

"Election" means a trustee election.

"General Voting Day" means the date on which general voting for a trustee election is to take place, whether part of the general school elections or a by-election.

"Minister" means the Minister of Education.

# 3. Application of Local Government Bylaws

- a. For a trustee election held at the same time as the general local elections, the election bylaws of the local governments regarding mail ballot voting and use of voting machines, as they may be amended from time to time, apply to the trustee elections to the extent authorized by the School Act, in accordance with the following: Trustee Electoral Area No. 1 (Belmont Zone):
  - a. The election bylaws of the City of Colwood regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the City of Colwood.
  - b. The election bylaws of the City of Langford regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the City of Langford.
  - c. The election bylaws of the District of Metchosin regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the District of Metchosin.
  - d. The election bylaws of the District of Highlands regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the District of Highlands.
  - e. The election bylaws of the Town of View Royal regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the Town of View Royal.
  - f. The election bylaws of the Capital Regional District regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the Juan de Fuca Electoral Area of the Capital Regional District.
- b. Trustee Electoral Area No. 2 (Milne's Landing Zone):
  - a. The election bylaws of the District of Sooke regarding mail ballot voting and use of voting machines apply for the purposes of school trustee elections and electors of the District of Sooke.

# 4. Mail Ballot Voting

- subject to the Local Government Act, voting and registration may be done by mail for those electors who meet the following criteria:
  - (i) persons who have a physical disability, illness or injury that affects their ability to vote at another voting opportunity;
  - (ii) persons who reside in a specified area of the jurisdiction for which the election is being held that is remote from voting places at which they are entitled to vote; and

- (iii) persons who expect to be absent from the trustee electoral area on general voting day and at the times of all advance voting opportunities.
- b. Procedures for mail ballot voting and registration may be established by separate bylaw.
- c. The Chief Election Officer may establish time limits in relation to mail ballot voting.

# 5. Appointment of Election Officers

The Board shall appoint a Chief Election Officer and a Deputy Chief Election Officer pursuant the *Local Government Act*.

#### 6. Resolution of Tie Votes after Judicial Recount

In the event of a tie vote after a judicial recount, the tie vote will be resolved by conducting a lot in accordance with the *Local Government Act*.

# 7. Required Advance Voting Opportunities

- a. Voting hours, at all required advance voting opportunities, shall be from 8:00 a.m. to 8:00 p.m.
- b. Unless the Board is exempted from the requirement by Order of the Minister of Education, an advance voting opportunity will be held on the tenth day before general voting day.
- c. Unless the Board is exempted from the requirement for a second required advance voting opportunity by Order of the Minister of Education a second advance voting opportunity will be held on the third day before general voting day.

# 8. Additional Advance Voting Opportunities

The chief election officer is authorized to establish additional advance voting opportunities for each election and to designate the voting places, establish the date and the voting hours for these voting opportunities.

# 9. Public Access to Nomination Documents and Campaign Financing Disclosure Statements

- a. The Board authorizes posting of nomination documents of trustee candidates on the website of School District No. 62 (Sooke) until 30 days after declaration of the election results.
- b. The Board authorizes, but does not require, chief election officers to post nomination documents of trustee candidates for public access on any or all of the websites of the City of Colwood, CRD, District of Highlands, City of Langford, District of Metchosin, District of Sooke and District of View Royal.

C.	The Board will make available to the public for inspection during the regular office hours
	of the Board's head office, the trustee candidates' campaign financing disclosure
	statements and supplementary reports until 5 years after general voting day either by
	providing:

- (i) access by internet, or
- (ii) a copy of that information for inspection

# 10. Repeal

School District No. 62 (Sooke) Trustee Elections Bylaw No. 1-14 is hereby repealed.

# **School Board Bylaw**

A bylaw to provide for the determination of various procedures for the conduct of general school elections and other trustee elections.

#### **Preamble**

Under Part 4 of the *School Act*, the Board of Education may, by bylaw, determine various procedures and requirements to be applied in the conduct of trustee elections.

In School District No. 62 (Sooke), seven (7) trustees are elected from the school district. Four (4) trustees will be elected (or appointed) for the Belmont Zone. Three (3) trustees will be elected (or appointed) for the Milnes Landing Zone. The term of office is four years. Elections will be at-large for each zone.

The school district election boundaries encompass the municipalities the District of the Highlands, Ci ty of Colwood, City of Langford, District of Metchosin, the District of Sooke, and the Capital Regional District.

The Belmont Zone and the Milnes Landing Zone.

The boundary between the Belmont and Milnes Landing Zone is described as follows: "Commencing at a point on high water mark of Beecher Bay, Strait of Juan de Fuca, being the southwesterly corner of Metchosin Land District; thence in a general northerly direction along the westerly boundary of the said Metchosin Land District to the southerly boundary of Goldstream Land District; thence northerly along the said westerly boundary of Goldstream Land District to the southerly boundary of Malahat Land District (being also the southerly boundary of the Esquimalt and Nanaimo Railway Land Grant); thence in a general easterly direction along the said southerly boundary of Malahat Land District to the easterly boundary of the Victoria Water Supply Area Goldstream watershed; thence northerly along said easterly boundary of the said Goldstream watershed to the northerly boundary of School District No. 62 (Sooke), being a point approximately one-half mile west of Wrigglesworth Lake, Malahat Land District."

Trustee elections which are the responsibility of the School Board may be conducted by the school board directly or by a local government under an agreement with the school board made pursuant to the *School Act* and *Local Government Act*.

The Board of Education, in an open meeting of the board, enacts as follows:

# 1. Definitions

The terms used shall have the meanings assigned by the *School Act, the Local Government Act*, and the *Local Elections Campaign Financing Act*, except as the context indicates otherwise. "Board" or "school board" means the Board of Education of School District No. 62 (Sooke).

"Chief Election Officer" means the official appointed by the Board pursuant to the School Act.

"Election" means a trustee election including general school elections and by-elections.

"General Voting Day" means the date on which general voting for a trustee election is to take place, whether part of the general school elections or a by-election.

"Minister" means the Minister of Education and Child Care.

"Local Government Act" or "LGA" – means the legislative instrument that governs aspects of the election process that are not addressed by the School Act.

**"Non-municipal electoral area"** means the trustee electoral area encompasses more than one. municipality and includes part of a regional district.

"School Act" – means the legislative instrument that governs the election process.

**"Trustee electoral area"** means the entire geographical area of School District No. 62 (Sooke)

# 2. Application

This bylaw applies to both general school elections and by-elections carried out by the school board and by other authorities, except as otherwise indicated.

# 3. Application of Local Government Bylaws

For purposes of harmonizing trustee elections with local government elections occurring at the same time, the elections bylaws of the following local governments, as they may be amended from time to time, and as they apply to Voting Opportunities including mail balloting and Use of Voting Machines will apply to voting in trustee elections carried out in conjunction with the respective local government elections, except as provided otherwise in this bylaw or in the *School Act*:

The Capital Regional District (Beecher Bay Reserve)
The District of Metchosin
The District of Sooke
The District of the Highlands
City of Colwood
City of Langford

# 4. By-Elections

- For elections held at times other than a general school board election, the procedures are outlined in Part 4, Division 3 of the *School Act*.
- Advance Voting Opportunities including mail balloting, voting places, and voting hours will be decided by the Chief Election Officer.
- Use of Provincial List of Voters:

Pursuant to section 76 of the *LGA*, the Board authorizes that the Provincial list of voters shall be the register of resident electors. Pursuant to section 69 of the *LGA*, the Board authorizes the Chief Election Officer to decide if electors not on the provincial electors list are able to register at the time of voting.

#### **5. Public Access to Election Documents**

- 5.1 The Board authorizes posting of nomination documents of trustee candidates on the website of School District No. 62 (Sooke) until 30 days after declaration of the election results.
- 5.2 The Board authorizes but does not require chief election officers to post nomination documents of trustee candidates for public access on any or all the website of the City of Langford, City of Colwood, District of Sooke, District of Metchosin, Capital Regional District, and District of the Highlands.
- 5.3 The Board authorizes posting of trustee candidates' campaign financing disclosure statements and declarations and supplementary statements and declarations on the website of School District No. 62 (Sooke) until one year from general voting day.

#### 6. Order of Names on the Ballot

The order of names of candidates on the ballot will be alphabetical in accordance with the *School Act* and the *Local Government Act*.

# 7. Resolution of Tie Votes after Judicial Recount

In the event of a tie vote after a judicial recount, the tie vote will be resolved by conducting a lot in accordance with the *School Act* and the *Local Government Act*.

#### 8. Number of Nominators

For certainty, the minimum numbers of qualified nominators for a trustee candidate are two.

#### 9. Nomination Deposit

No nomination deposit is required for nomination for the office of school trustee.

# 10. Repeal

School District No. 62 (Sooke) School Trustees Elections Bylaw No. 1-18 is hereby repealed.

# 11. Title

This bylaw may be cited as "School District No. 62 (Sooke) Trustee Elections and By-Elections Bylaw No. 1-23."
